



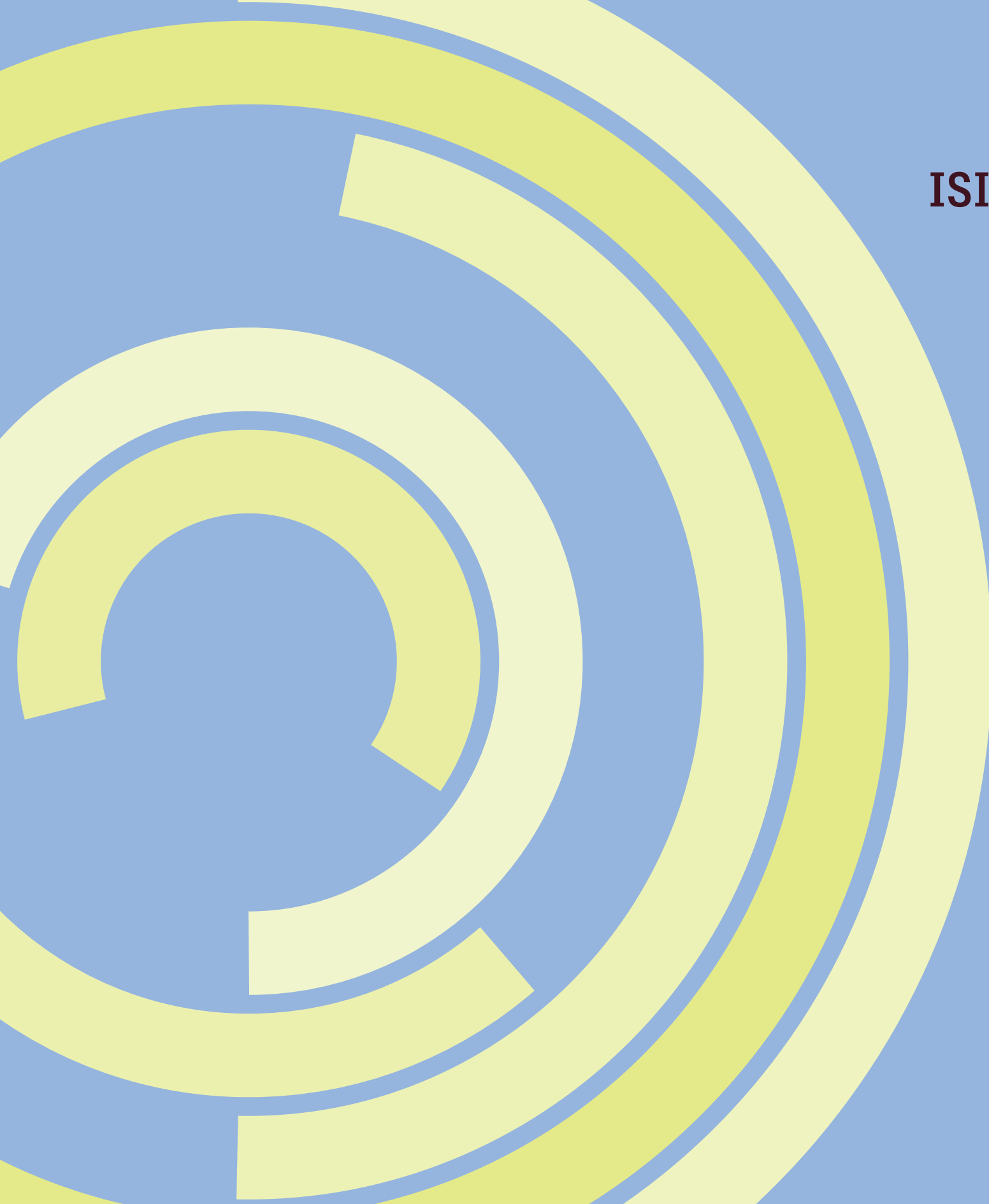

The Institute of Strategic & International Studies (ISIS) Malaysia was established on 8 April 1983 with a mandate to advance Malaysia's strategic interests. As an autonomous research organisation, we focus on foreign policy and security; economics and trade; social policy and nation-building; cyber and technology; and climate and energy.

We actively conduct track-two diplomacy, promoting the exchange of views and opinions at the national and international levels. We also play a role in fostering closer regional integration and international cooperation through various forums, such as the Asia-Pacific Roundtable, ASEAN Institutes of Strategic & International Studies network, Council for Security Cooperation in the Asia-Pacific, Pacific Economic Cooperation Council, Network of East Asian Think-Tanks, Network of ASEAN-China Think-Tanks and ASEAN-Australia-New Zealand Dialogue.

PRAXIS AND *THE PRAXIS PROCESS*

PRAXIS is ISIS Malaysia's flagship public policy conference, designed to bridge ideas and translate theory into practice. Since 2011, PRAXIS has convened policymakers, the private sector, civil society and academia to engage in topics of national interest.

PRAXIS distinguishes itself through the PRAXIS process – embedding a research process to deliver impact from end-to-end. This process begins well before the conference with closed-door roundtables and consultations that bring together stakeholders and policymakers to identify core issues, shape agendas and frame the questions that matter. Post-conference, discussions are synthesised with cutting-edge analysis from ISIS Malaysia's researchers to produce actionable, pragmatic policy briefs to help advance dialogue to decision.



THEME

As Malaysia approaches 70 years of independence and its major national plans converge on 2030, PRAXIS 2026 asks a deceptively simple question: what comes next? High income, this year's premise insists, is a starting point – not a destination.

Even the world's wealthiest nations are grappling with ecological strain, eroding trust and rising insecurity. Approaching 70 years of independence and looking past the 2030 national milestones, this flagship conference bridges high-level policy with the creative aspirations of Malaysia's youth. By translating theory into concrete institutional choices, PRAXIS 2026 gathers policymakers, experts and the next generation to redefine progress and design a secure, shared future for all Malaysians.

YB Dato' Sri Azalina Othman Said

Azalina has held her current portfolio since December 2022. In overseeing the Legal Affairs Division, she actively spearheads major national governance and institutional reforms, including the drafting of the progressive AG-PP Bill to separate the roles of the attorney-general and public prosecutor and proposals for fixed-term limits for the prime minister. She is a former minister of youth and sports, tourism minister and Dewan Rakyat deputy speaker. A lawyer by training, she has contributed significantly to legislative oversight by chairing multiple parliamentary select committees focused on critical socio-legal matters and institutional reforms.

Faiz provides high-level counsel to the government on geopolitics, defence and security, as well as the evolving landscape of global geoeconomics. At ISIS Malaysia, he spearheads policy innovation and leads strategic track-two diplomacy. He is the Malaysian representative to the ASEAN Regional Forum Experts and Eminent Persons, and co-chair of the Council for Security Cooperation in the Asia-Pacific. He is also a member of the World Economic Forum's Global Future Council on Good Governance and a distinguished adjunct professor of the International Islamic University of Malaysia.

EXPERT KEYNOTE

What if the thinking and policies that have got countries to where they are today are no longer the thinking and policies that meet the challenges of our times? What if instead of the assumption that more economic growth, more profit and more money are always the answer, an economy that is designed and delivered to meet the needs of the people and planet is what countries need to prioritise? This talk will outline why it is time for a wellbeing economy, what that means for policy and enterprise, and what it looks like in practice.

Trebeck is a political economist, writer and advocate for economic system change. She is also a strategic adviser to the Centre for Policy Development and teaches at the University of Edinburgh. She is a distinguished visitor at the Australian National University's Planetary Health Equity Hothouse; 2024 thinker-in-residence at the Australian Health Promotion Association; new economics senior fellow at the Zoe Institute; and fellow of The Post Growth Institute. She co-founded the Wellbeing Economy Alliance (WEAll) and WEAll Scotland. She instigated the group of Wellbeing Economy Governments (WEGo) — comprising Scotland, New Zealand, Finland, Wales, Iceland and Canada — the story of which is the subject of the documentary *Purpose*.

CONCURRENT SESSION 1A

FUTURE OF PUBLIC SERVICES AS THE SOCIAL COMMONS

This concurrent session imagines a future in which public health, education and social care serve as shared social foundations for everyone, rather than as services increasingly shaped by private markets. It asks how these systems could operate as social commons that are: universally accessible and high quality; organised around dignity, care and capability; and designed so that people across income groups and regions can live, learn, work and age well. What would everyday life feel like if health, education and care formed the bedrock of Malaysia's wellbeing? Why is recentring these foundations essential for a resilient post-high-income Malaysia and what are the policy and institutional changes needed to make this shift possible?

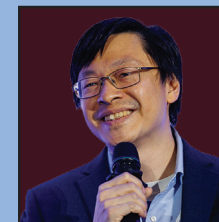
Kularetnam Vijayakumar

CONCURRENT SESSION 1B

FUTURE OF PROSPERITY WITHIN ECOLOGICAL BOUNDARIES

This concurrent session looks towards futures in which Malaysia thrives within ecological limits while expanding opportunities for human flourishing. It considers what it would mean to treat land, water, forests, cities and energy systems as shared ecological commons, managed to sustain life and livelihoods over generations rather than to maximise extraction for short-term gain. Panellists will explore how such futures could reshape development priorities, spatial planning and risk management in the face of climate risk and environmental degradation. What might a liveable, lower-carbon Malaysia look like for households and communities? How could aligning economic choices with ecological realities underpin a more secure, just and prosperous post-high-income future?

Goh's career spans research, education, government and intergovernmental organisations. He began his career as a researcher at Utrecht University in the Netherlands, where he participated in projects on international trade and large-scale investments in the bioeconomy, conducting extensive field studies in Kalimantan. He subsequently worked at Malaysia's National Innovation Agency, where he was involved in the implementation of the National Biomass Strategy 2020, with a particular focus on Malaysian Borneo. His monograph, *Transforming Borneo: From Land Exploitation to Sustainable Development*, was published in 2023.

Nithi joined EPSM, an all-volunteer-run society, in 1983. Under his tenure as president, the society introduced three sustainability instruments in Malaysia — Local Agenda 21, Global Reporting Initiative and ecological footprint analysis — as part of its sustainable living in Malaysia programme. He is also director and regional coordinator of Climate Action Network Southeast Asia, which comprises 40 civil society organisations in 10 countries. He has been a participant in the Conference of Parties (COP) of the United Nations Framework Convention on Climate Change since COP6.

Serina is an associate fellow in the Malaysia Studies Programme at ISEAS-Yusof Ishak Institute, Singapore. She teaches environmental politics, religion, magic and anything about Southeast Asia by sea. Trained as a conservation scientist specialising in seagrass human-habitat interactions, her practice is in community empowerment through citizen science, community research and ecotourism. She also studies artisanal fisheries resource management at Kelab Alami, a community organisation in Johor that she co-founded in 2008. Her research includes (un)sustainable development, Malaysian rural politics and political ecology. Serina is an Iskandar Malaysia social hero award winner for environmental protection and Malaysia's ambassador for Citizen Science Asia.

CONCURRENT SESSION 2A

FUTURE OF WORK AND TIME

This concurrent session looks towards futures in which work and livelihoods in Malaysia are organised around security, time and voice, alongside income. Panellists will imagine what “good work” and “time to live” could look like in a post-high-income Malaysia: stable livelihoods, working hours compatible with care and rest, and workplaces where people have a meaningful say over their conditions. How might changes in labour standards and social protections – as well as different ways of organising jobs, workplaces and ownership – reduce precarity and stress while supporting innovation and productivity? What would it take for work to support, rather than undermine, a good life?

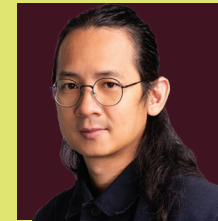

CONCURRENT SESSION 2B

FUTURE OF MALAYSIA'S PLACE IN A NEW WORLD

This concurrent session looks beyond Malaysia's borders to imagine possible futures for how the country engages with the world amid fragmentation, war and climate collapse. It will explore visions for a post-high-income development model oriented towards peace, shared prosperity and mutual benefit, rather than extractive growth models or volatile external markets. Panellists will consider how these futures could reshape Malaysia's trade and industrial strategies, partnerships with the Global South and place in a new world economic order. What role could a post-high-income Malaysia play in shaping a more just and inclusive global economic community in the coming decade? And how could external engagement, in turn, better serve the wellbeing of all Malaysians?

Yeah was appointed professor of economics at Sunway University in 2016. Prior to academia, he spent nearly three decades in the private sector, most notably as chief economist at the country's pioneer credit rating agency. He currently serves as president of the Malaysian Economic Association and as a member of the National Wage Consultative Council, as well as the Policy Advisory Committee to the Prime Minister. He is also a former external member of Bank Negara Malaysia's Monetary Policy Committee.

SESSION 3

FROM FUTURE VISIONS TO CHOICES IN THE PRESENT

This closing plenary explores the contours of a hopeful, post-high-income Malaysia that have emerged from today's conversations. Drawing on the futures articulated in the domain sessions and the pre-conference visioning exercise, panellists will consider what these visions suggest about the meaning of progress for Malaysia, and how this compares with the direction in which current institutions, plans and incentives are pointing. They will also examine present-day constraints – fiscal, institutional and social – to identify the near-term choices in policy, institutions and practice that hold the most promise. How, within the limits of the present, can we begin to prefigure the Malaysia we are trying to become?

Nurhisham currently serves as head of the secretariat of Pasukan Petugas Pengurusan Krisis (Crisis Management Task Force). He plays a key advisory role, supporting the prime minister on matters relating to the economy, investments and capital markets, social protection, and other relevant areas. He is a former chief strategy officer at the Employees' Provident Fund (EPF) and served as head of the Economics and Capital Markets Department, overseeing economic surveillance of more than 20 global economies and contributing to EPF's investment process. He presently sits on the board of directors of ProtectHealth Corporation Sdn Bhd, a Ministry of Health company.

Marshall is part of the Office of the UN Resident Coordinator for Malaysia, Singapore and Brunei. His specialisms include poverty analysis, including multidimensional poverty, growth and inequality dynamics, social protection reforms and industrial policy. In Malaysia, his work focused on the socioeconomic impacts and policy responses to the Covid-19 pandemic; the tracking and reporting of Sustainable Development Goals performance, including supporting Malaysia's Voluntary National Reviews in 2021 and 2025; and research into the challenges faced by the undocumented population in Sabah.

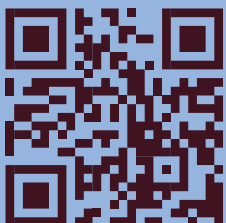
